	Recovery of official error overpayments and case update
	The DWP has discretion to waive benefit overpayments, but rarely does so. This session will discuss the DWP's current policy on overpayment recovery and

preparing waiver requests. Emma will also update on the recent case of R(K) v Secretary of State for Work and Pensions in which the High Court found that DWP acted unlawfully in refusing to waive the claimant's UC overpayment debt, having wrongly advised her that she was entitled to the money.

Seeking surviving co-habitees

Almost five years after the Supreme Court decision in *McLaughlin* [2018] UKSC 48 and three years after the High Court decision in *Jackson and others* [2020] EWHC 183 (Admin), the DWP has finally brought in the Bereavement Benefits (Remedial) Order 2023 which enables surviving cohabitees with children to claim bereavement benefits following the death of their partner. While the Order only came into force on 9 February 2023, it has retrospective effect from 30 August 2018 bringing eligibility to individuals who would have had entitlement to either bereavement support payment or widowed parent's allowance as at that date.

This session explores the details of the Order - including how and when to make a claim, and how payments will be treated - and also seeks to discuss how NAWRA might assist in getting the message out to potential claimants, some of who may have been bereaved as long ago as 2000.

A. Social Security Decisions and Aspects of European Directives & Sections Patrick Hill

11.30am and 2.30pm workshop sessions

While the topic in question will, I suspect, raise the odd eyebrow or so, and, indeed, promote the odd yawn or two, its aim and presentation is intended to achieve quite the opposite. It is to introduce advisors to a surprisingly little used tactic in challenging decisions; whether via review, or, more likely, appeal. I speak of the use of the principles of EU Directives & Articles of the HRA. No, please, before the reader moves to another topic, this piece of work explains in the simplest and briefest of ways, that it dispels any mystique held by some about such an apparently lofty subject. The content will rely, in the main, on two issues 1) The case concerning equal treatment in matters of social security (79/7 EEC) of *Evelin Thomas & Others 'v' Secretary of State for Social Security*, and the guidance offered therein by Lord Justice Slade, and 2) the interaction between the *Thomas* case, and the general right to appeal offered in article 6(1) of the HRA.

B. Impact of freezing Local Housing Allowance rates

This continuous freeze is resulting in an average shortfall of £146 per month.

In November last year, the government announced that Local Housing Allowance rates will be kept at the level first set in April 2020. So, while rents are rising at their fastest rate in 16 years, many people are now finding their welfare payments are nowhere near enough to cover the rent. In fact, more than half of private renters who receive Housing Benefit or Universal Credit are in this situation.

The workshop will highlight the impact of the rent shortfall. Not only this makes it difficult to cover their housing costs, but they may also face difficulties moving to somewhere cheaper due to their circumstances. This will particularly be the case where a child has mental health or neurodiverse condition/disability such as Autism or ADHD. They would find moving house extremely difficult. As their parents need to look after them it is unlikely the parents would be able to make up the shortfall through work.

C. Housing Benefit and supported housing

The English Social Housing Regulator has been taking a keen interest in the rents charged by providers of "exempt" supported accommodation. This workshop looks at the typical breakdown of the rent payable for a supported housing scheme, including the costs that contribute to the "core rent" and service charges. With few self-funders in exempt accommodation, the costs are normally funded by HB. Local authorities are showing an increasing willingness to challenge what they regard and exploitative and excessive rents, both in the regulated social sector and in the charitable/voluntary sector. The workshop will summarise the mechanisms available to local authorities and the evidence burden they face if they want to take on a rogue provider. The session touches on "specialised supported housing" (SSH), properties owned by investors and leased to RPs, and the rather vague concept of "intensive housing management".

Tom Evans is a Solicitor and Court of Protection Deputy at Qualia Law CIC, a non-profit advice and support organisation specialising in mental capacity and financial

safeguarding. Qualia Law is the only non-profit in the UK to provide Court of Protection Deputyship by qualified Solicitors.

Tom will provide an overview of:

- the role of the Court of Protection
- the differences between a Lasting Power of Attorney and Deputyship
- recognising mental capacity and financial abuse
- how and when to refer for specialist advice

By public transport:

 From <u>Redbridge Park and Ride</u> take the <u>X3 City bus</u> towards the city centre/Barton and alight at 'Northway Copse Lane' then walk for ten minutes along Copse Lane to the venue.
