# 2.10 Universal credit deductions: update on PLP's ongoing research Jagna Olejniczak (Public Law Project)

Public Law Project is gathering evidence into the issues claimants face when dealing with universal credit deductions. Jagna will share the initial findings on the awareness and accessibility of options that should be available to mitigate the hardship caused by reduced allowance (including suspension of repayments, reduction of their rate and waiving the debt which led to the deductions) and the barriers to challenging the overpayment decision. # 9.40 Towards a trauma-informed social security system: Lessons from the Sanctions, Support and Service Leavers project

Lisa Scullion, Professor of Social Policy and Co-Director of the Centre for Research on Inclusive Society at the University of Salford

This presentation reflects on findings of a <u>five-year research project focusing</u> <u>on veterans' experiences of the benefits system</u>, which has helped to advocate for the integration of trauma-informed practice within the benefits system.

Lisa is Professor of Social Policy and Co-Director of the Centre for Research on Inclusive Society at the University of Salford. Lisa has delivered over 60 research projects, with a commitment to the importance of qualitative inquiry for shaping policy and practice. Lisa's work focuses specifically on understanding the impact of UK welfare reforms.

#### 10.10 The Advice Quality Standard - how can it help you?

Jo Chimes (Advice Services Alliance)

The Advice Services Alliance is fiercely proud of the <u>Advice Quality Standard</u> (the AQS) and the role it plays in driving the development of access to social justice in this country. The AQS is held by over 600 separate local advice services across England and Wales who provide advice on social welfare legal problems.

It is a standard which is owned and driven by the sector itself and yet is independent of any of the national advice networks or any individual funders or regulators. This session will look at the benefits of the AQS, and the work ASA is doing to better understand some of the current challenges for advice organisations, and how we can help to provide support to meet those challenges.

We will also explore what makes a quality advice service, with lots of practical tips and ideas. For example: how can you demonstrate the value of the advice you give; what does strategic advice-giving look like; and how to prevent 'adviser burnout'.

This session from the Advice Services Alliance will be practical, interactive and with lots of opportunity to discuss and ask questions.

#### 10.50 Getting LCW/LCWRA status for people who are in work

Lindsay Fletcher and Sarah Batty (The Benefits Training Co)

It is often possible for the Work Capability Assessment to be carried out in universal credit when a claimant is working.

This presentation looks at the process and implications for achieving Limited Capability for Work (LCW) / Limited Capability for Work Related Activity (LCWRA) status for claimants who are in work.

#### What will be covered?

- How and when is it possible to have the Work Capability Assessment process started for people who are in work?
- How can I ensure income is maximised via the UC work allowance as well as via the LCWRA element for people who are in work?
- When is a disability benefit needed and what happens if it is awarded retrospectively?
- How is it different for the 'treated as' rules (e.g. cancer treatments)?
- The 16-hour x National Minimum Wage rule how can I make sure earnings are assessed correctly?

# 11.45 Re-revising decisions - lapsed appeals

The DWP practice of further reviewing decisions once appeals have been lodged is fairly common practice. The process for these further revisions and lapsing of appeals is subject to Best Practice guidelines to ensure fairness and transparency. In practice, it would appear that the guidelines are not being followed and the report 'Quality Focus? The Reality of Lapsed Appeals', investigates some of the concerns arising for appellants as a result of noncompliance with the Best Practice Guidance.
